Office Fee: \$35 per horse.

Haul-In Fee: \$20 per horse (only for horses not reserving a stall).

Stabling: Day stalls \$50 | \$15 per bag bedding. Stalls are not pre-bedded.

Test of Choice classes may be scored together if fewer than six riders are entered.

Property Damage: Participants are responsible for damage over \$50 caused by their horse.

Footing: Two outdoor sand arenas and one indoor fiber footing arena. Lunging not permitted in indoor arena.

Entries: Must be submitted online with full payment, negative current Coggins, Flu/Rhino vaccination record, and signed release.

Helmets: ASTM/SEI approved helmets required at all times while mounted.

Post Entries: Accepted at management discretion with 50% additional fee.

Refunds: Full refund (less office fee) prior to closing date. No refunds after closing date.

Ride Times: Posted on ADA website and Lone Tree Stables platforms.

Facilities: Port-a-John available on site.

Dogs: No dogs permitted on property.
